 - ii. Erika: We field some concern about wait time, especially during July-August because we're the only indoor court around that's open during that period
 - iii. Blake: Can we tell what municipalities are represented? Wondering if it's a group coming over to play
 - iv. Ramiro: It's a good spread. Some as far as Abilene. But mostly Flower Mound, Denton, etc
 - v. Chery: how much are memberships?
 - vi. Erika: 20 & 30, 50 & 75 annual
 - vii. Angela: Once you start charging for membership at Herring, will that balance out the income?
 - viii. Erika: Yes
 - ix. Elaine pointed out an error in the slide before "TOTAL SCANS FOR THRIVE: MEMBERSHIP SCANS -THRIVE" slide it had to do with the pricing
 - x. Asterisk should be by August on Total by Month slide
 - xi. Title of slide for Usage per day by Month should have a different title from "THRIVE OPEN PLAY"
 - xii. Julia: the nets (at SV) aren't provided? (clarified by Blake)
 - xiii. Even public use?
 - xiv. Erika: a lot of Pickleball players have their own, but otherwise they can rent from us
 - xv. Elaine: if you rent a court at SV, how do you kick people out that are using them for free?
 - xvi. Ramiro: We haven't had a problem but you can show your receipt, can escalate to Park Ranger, whose number is provided on the receipt
 - xvii. Angela: If you rent the net in the evening, can you return in the morning?
 - xviii. Erika: Yes, you can return until 9pm or the next morning at Thrive
 - xix. Julia: With expanded hours, would revenue be expanded?
 - xx. Erika: we'll look at that. In April, people will be required to purchase separate memberships for Thrive & Herring.

 - xxii. Erika: We can break it down through looking at memberships. We mostly see seniors. A handful of YAs. We can provide that data for you
